- These are nonprofit organizations founded primarily from a single source, such as an individual, family or corporation, and managed by its own trustees or directors, and are organized either as a nonprofit corporation or as a charitable trust. A PF has strict rules that must be followed to maintain its tax exempt status.. Classification as a PF will affect overall percentage of deductibility for tax deductions purposes.
